SUMMARY On Saturday, 03/08/25, at approximately 3:35pm, Milwaukee Police Department (MPD) Ofc. Andrew Schnell shot Anthony Z. Virginia (M/W, ■■■-83). MPD Officers were investigating a report of a burglary and shots fired incident at 51■■■ N. 32 St. Officers located two suspects (Andrew Virginia and Orlando M. Lagar (M/W, ■■■-91)) near the railroad crossing at N. 37 St. and W. Lancaster Ave. Both Virginia and Lagar fled on foot from officers. Ofc. Schnell shot Virginia after he produced a handgun and pointed it at Ofc. Schnell. Virginia was transported to Froedtert Hospital where he died from his injuries. In accordance with Wisconsin State Statute 175.47, the Milwaukee Area Investigative Team responded and investigated the use of force. The Wauwatosa Police Department was the lead investigative agency.

In accordance with the Milwaukee Area Investigative Team (MAIT) MOU, Lt. Kupusta turned the officer involved shooting investigation over to me.
